2 Minutes of the previous meeting.

The minutes of the previous meeting held on 5th October were accepted in full.

3 Feedback from General Committee meetings

Apart from a decision that the club declared there would be no roll ups in the period from Christmas to the New Year, PC stated that there were no specific issues arising which impacted the Seniors section.

4 Treasurer's Report

GP had circulated a financial report prior to the meeting. He stated that the finances were in good condition. Current liabilities included £240 for Winter League prizes, £124 for the Captains' Charity and prizes for the winners of the Champion of Champions competition.

GP confidently expected the section to breakeven on the year and carry assets of £900 into 2024.

5 Awaydays / Tour reports

5.1 Feedback from the Bristol tour

Overall feedback was favourable and the event was enjoyed by those participating. A small number commented that the Burnham and Berrow course was too difficult. This led to a discussion about the level of difficulty the courses should be for the tours.

It was agreed that a variety of courses, some reasonably difficult and others less challenging, should be considered for future tours. The slope ratings should be taken into account but not taken as the sole discriminator when selecting courses.

5.2 Future Tours and Awaydays

JP led a discussion about the venues for future tours and awaydays. It was agreed that Newbury and Cookham, Stratford and Caversham were good potential awayday courses.

In the same way, venues for the Spring tour were considered. It was agreed that the Welsh National and Hawkstone Park are both suitable.

JP will investigate with regard to availability and costs, and consideration JP of the SW diary and start booking the Spring events in further discussion with TM.

6 Proposed draft roll up schedule for December

PC led a brief discussion about the previously circulated draft schedule. A minor change was made and it was agreed that the Christmas Shotgun event would be played off the Cobalt tees.

Following discussion it was agreed that players not in the Winter League CF & RI but playing a general round on the day of a Winter League event, are welcome but should be scheduled to tee off after the Winter League participants.

7. Issues with countback and results from Club V1 and HDID

The Division 2 result of the Memorial Trophy has led to a perceived discrepancy in terms of who had actually won the competition.

There was also disagreement about when the competition was actually closed.

DH explained that this discrepancy had occurred because the competition had been closed on HDID using gross, not net scores.

Following a lively discussion about this previously unknown fact, and the variability of dates when Senior competitions were closed, it was agreed that:

7.1 Competition organisers are to close competitions in the evening, at the latest, of the day when the relevant competition had been played.

Discussion arose about the number of people having the appropriate PC access codes (to HDID) to enable them to set up and close competitions.

It was agreed that only relevant committee members should be





permitted to use these codes and that those no longer on the committee should now have their access withdrawn.

8. Competitions update: Pairs KO, Memorial Trophy Medal, Champion of Champions

The committee congratulated the winners of the Pairs Knock-out competition namely Geoff Gaskins and Vic Churchley, the Memorial Trophy, Peter Collingwood, and the new Champion of Champions, Geoff Skiller.

9. M4 League

TM reported that the SW team currently lie second in the M4 League table with a win and a draw. Unfortunately two matches have had to be rearranged due to bad weather, which has impeded SWs progress in the competition.

Dates for the rearranged matches have yet to be finalised.
